Dear Michael:

Last week I faxed you a copy of my Motion to Withdraw from representation in this matter. This, and the companion case Atlantic Lending v. Berman Mortgage, Case No. 05-14867, were lawsuits arising from a Berman deal and I substituted in for James on both cases the month you became Receiver, December of 2007.

I have tried to withdraw from the cases for a very long time but Robert Miller is making it very difficult. I successfully withdrew from the first matter against Berman Mortgage (a copy of the Order is attached), but I waited to withdraw from the second case until James and Robert Miller reached a Settlement of the Atlantic Lending issues with BMC Lenders. You have been copied on each filing since then as a courtesy. At the time I initially moved to withdraw and waited until James and he reached an agreement, Robert Miller was attempting to take the depositions of all the Lenders involved in this loan. He is doing the same now so I am unsure what agreements or protections were built in for the lenders with regard to this issue but this is something they should be warned about.


Now, Mr. Miller insists that I notice my Motion to Withdraw to all the Lenders which is why I have faxed you copies of the last two Motions. He has also filed a Motion to Disclose my Putative (MAMC lender) Clients which I Represent(ed). As of yesterday, I see that neither of the Motions has been posted on the Court Filings website, so I am asking that you do so. I can file a Notice of Filing in the Receivership case, with a copy of my Motion to Withdraw, but I didn't think you would find that necessary.
