RECEIVER'S MOTION TO TRANSFER CASE

Michael I. Goldberg, the receiver (the "Receiver") for M.A.M.C. Incorporated ("MAMC"), hereby files this *Motion to Transfer Case* (the "Motion"). In support of this Motion, the Receiver states as follows:

1. Michael I. Goldberg files this Motion in his capacity as the Receiver for plaintiff MAMC and with the consent of plaintiffs Gerard R. Collins and the additional lenders.
2. Pursuant to that certain *Temporary Injunction and Agreed Order Appointing Receiver*, dated December 11, 2007, the Receiver was appointed receiver over MAMC, Berman Mortgage Corporation, and Relief Defendants DB Atlanta, LLC, *et al.*, (the "Receivership Defendants") by the Circuit Court of the Eleventh Judicial Circuit in and for Miami-Dade

County, Florida (the "Receivership Court") in *State of Florida, Office of Financial Regulation v. Berman Mortgage Corporation, et al.*, Case No. 07-43672 CA 09 (the "Receivership Case").

3. The Receiver was appointed to prevent the waste and dissipation of the Receivership Defendants' assets to the detriment of investors who entrusted over \$192 million ("Investor Funds") to the Receivership Defendants.

4. The Investor Funds were secured by mortgages on approximately 40 different real estate projects and properties, including a loan made to V-Strategic, LLC ("V-Strategic") for the purchase of a parcel of land located at 2101 East Hallandale Beach Boulevard, Hallandale Beach, Florida (the "Property"). The V-Strategic loan was evidenced by a Promissory Note and secured by a First Mortgage and Security Agreement (the "Mortgage") against the Property. Moreover, Juan Ventura and Jose Ventura (jointly, the "Guarantors") executed a Guaranty, personally guarantying full and prompt payment of obligations under the Promissory Note, including any modifications thereto. The total amount of the loan as modified, was \$8 million.

5. Prior to the receivership case, MAMC serviced the loan made to V-Strategic. After V-Strategic defaulted, on March 31, 2009, the Receiver's counsel, on behalf of Gerard R. Collins and the other investors who contributed to the V-Strategic loan (the "Lenders") and MAMC (collectively, the "Plaintiffs"), filed this case (the "Foreclosure Case") on behalf of the investors. The Plaintiffs asserted three causes of action: Count I - Foreclosure; Count II - Breach of Promissory Note; and Count III - Breach of Guaranty.

6. On November 12, 2009, upon the Plaintiffs' Motion for Partial Summary Judgment on Counts I and II, this Court entered a Partial Final Judgment in favor of the Plaintiffs. On July 22, 2010, the Plaintiffs assigned the Partial Final Judgment and right to bid at the foreclosure sale to MAMC V-Strategic, LLC, a single purpose entity created by the

Receiver to hold title to the Property. The foreclosure sale took place on July 28, 2010. MAMC V-Strategic, LLC was the successful bidder and on August 10, 2010, the Clerk of the Court filed a Certificate of Title on behalf of MAMC V-Strategic, LLC.

7. On August 17, 2010, the Receivership Court entered an Order expanding the receivership estate to include MAMC V-Strategic, LLC as a relief defendant. ("MAMC V-Strategic").

8. The Receiver marketed the Property for sale. On June 18, 2012, the Receivership Court entered an Order approving the sale of the Property to CVS Caremark Corporation ("CVS") through its affiliate, CVS 10078 FL, LLC, for the sum of \$5,900,000.

9. The sum of \$5,274,044.90 was available for distribution to the Lenders, after payment of prorated real property taxes and closing costs, attorney's fees and loans (made with other funds in the Receivership Case) to pay expenses and prior years' real property taxes. This sum represents a 65.93% return on the Lenders' principal investment. On September 19, 2012, the Receivership Court authorized the Receiver to make a partial distribution to the Lenders.

10. The Lenders engaged the Law Offices of Robert L. Parks PL to recover the remaining amounts owed on the V-Strategic loan. On September 27, 2012, the Lenders filed a Complaint against the Guarantors in the Circuit Court of the Eleventh Judicial Circuit in and for Miami-Dade County, Florida, Case No. 2012-038306-CA-01 (the "Contract Indebtedness Case").

11. As one of their affirmative defenses in the Contract Indebtedness Case, the Guarantors asserted that there are presently two pending actions in two separate circuit courts.

12. The Contract Indebtedness Case has been active since its inception. A true and correct copy of the docket for the Contract Indebtedness Case is attached hereto as Exhibit 1.

13. As demonstrated by the docket in this case, there has been no action in this Foreclosure Case since August 10, 2010, the date that the Certificate of Title was issued. A true and correct copy of the docket in the Foreclosure Case is attached hereto as Exhibit 2.

14. Through this Motion, the Receiver, seeks to transfer the remaining portion of the Foreclosure Case into the Contract Indebtedness Case.

MEMORANDUM OF LAW

Where two actions between the same parties are filed in different circuits, venue normally lies in the circuit where service of process is first perfected. See *Mabie v. Garden St. Management Corp.*, 397 So.2d 920, 921 (Fla.1981). In *Ray v. Williams Phosphate Co.*, 59 Fla. 598, 52 So. 589 (1910), the supreme court recognized that the facts of a given case may justify an exception to the general venue rules. See *Beckmann v. Burdette-Beckmann, Inc.*, 564 So.2d 649 (Fla. 4th DCA 1990) (reversing order changing venue because an exception to *Mabie* was not supported by facts in the record). Section 47.122, Florida Statutes, allows for such an exception in its provision that a court may transfer venue "in the interest of justice." See *Triad Discount Buying Services, Inc. v. Special Data Processing Corp.*, 761 So.2d 1181, 1182 (Fla. 4th DCA 2000).

The factors outlined in § 47.122, Florida Statutes authorize the transfer of the Foreclosure Case to Miami-Dade County and into the Contract Indebtedness Case. The statutory factors a court considers in determining whether to grant a motion pursuant to § 47.122 are (1) the convenience of the parties; (2) the convenience of the witnesses; and (3) the interest of justice. See *Ford Motor Co. v. James*, 33 So.3d 91, 92–93 (Fla. 4th DCA 2010); § 47.122, Fla. Stat. The Guarantors reside in Miami-Dade County; the foreclosure portion of the Foreclosure Case has been completed, so there is no longer a nexus to Broward County; the parties have been litigating

the Guarantors' liability in the Contract Indebtedness Case for three years, while there has been no activity of record on Count III in the Foreclosure Case.

A Court may transfer venue of action based on convenience of parties or in interest of justice. *See Imperatore v. NationsBank of Florida N.A.*, 677 So.2d 933 (Fla. 4th DCA 1996). Although venue in Broward County may not be improper, a court may grant a motion to change venue to another county which was strongly connected with suit for convenience of parties or witnesses or in interest of justice. *See Lanthan Const. Corp. v. McDaniel Grading, Inc.*, 695 So.2d 354 (Fla. 5th DCA 1996). The circumstances of these cases warrant the transfer of the Foreclosure Case to Miami-Dade County, Florida and into the Contract Indebtedness Case.

Wherefore, Michael I. Goldberg, in his capacity as Receiver of MAMC and related entities, respectfully requests this court enter an Order transferring this case to Miami-Dade County and into the Contract Indebtedness Case and for such other relief as is just and proper.


